### RESULTS OF THE EXTRAORDINARY GENERAL MEETING

#### 1. Introduction

Shareholders are referred to the Extraordinary General Meeting ("EGM") announcement dated 21 August 2024 regarding the Deregistration of Pamodzi Hotels Plc ("Pamodzi" or the "Company") with the Securities Commission following the Mandatory Offer made by ASB Hospitality LLC to Pamodzi minority shareholders.

### 2. Results of the General Meeting

Shareholders are hereby advised that the requisite majority of Pamodzi shareholders eligible to vote at the General Meeting held on 16<sup>th</sup> September 2024, approved all the ordinary resolutions as set out below in the manner required by the Companies Act and the Listings Requirements.

• The Deregistration Resolution.

The Deregistration of Pamodzi shares will occur following the Delisting of Pamodzi shares from the Lusaka Securities Exchange ("LuSE"). The effective date of the listing will be  $16^{th}$  October 2024 as requested by the Company in its application letter to the LuSE for the Delisting of its shares, in line with Clause 1.16 of the Listings Rules.

### 3. Trading Post the Deregistration of Pamodzi Shares with the SEC

Following the deregistration of Pamodzi Shares with the SEC, any trading of Pamodzi shares may attract a Property Transfer Tax ("PTT") as the trade will not take place on the LuSE but will take place privately, referred to as Over the Counter ("OTC"). Shareholders who wish to sell their shares are advised to do so before the deregistration of Pamodzi shares with the SEC is effected.

### 4. ASB Hospitality K4.62 Offer

ASB Hospitality has informed the Board of its intention to continue with the cash offer of K4.62 to all remaining minority shareholders. The K4.62 offer is valid until the last day to trade on the LuSE (16 October 2024).
